3. Finances

#### 3.1. Result & balance sheet 2022

BD asks BCECC Treasurer, Erik Famaey, to read his report:

Amid some relief from the covid crisis, the chamber could increase its 2022 'own revenues' by 7% to nearly  $\notin$  132.000. The slight pick-up was thanks to a near doubling of the 'activity fees' which are the amounts paid by participants joining events, and despite a very small decrease in membership fees which remain close to  $\notin$  100.000.

The chamber's self-generated income made up 72% of its total revenues with the other part provided by subsidies, mainly the  $\in$  40.000 received yearly from Flanders Investment & Trade under the strategic partnership agreement to be renewed every five years.

The chamber's operating expenses did not undergo notable changes. In particular the cost of the secretariat remained at  $\notin$  90.000. Worth mentioning is that the aforementioned doubling of activity fees did not come with a corresponding increase in the cost of staging the events. This may be one outcome of the digital instead of inperson format of most events.

2022 accounts closed with a positive result of  $\in$  30.611 which adds to the comfortable financial status of the chamber.

## 3.2. Budget Forecast

#### 2022

The Chamber was able to increase its own revenue by 7%, despite the fact that there has been a slight decrease in the membership fees in 2022, seeing that the activity fees have increased quite a lot compared to last year.

#### 2023

BD does not foresee many changes in the finances of the Chamber in the coming year.

BD finally moves to the approval of the result and balance sheet for 2022 as well as the budget forecast for 2023, which are all approved by the Board members.

#### **1.** Number of members

BD moves to the number of members and compares the numbers of 2022 and 2023, noting a slight increase in membership. This shows that despite the difficult geopolitical situation and the economic recession in China, the membership of the Chamber remains stable.

BD mentions that Mr. Philippe D'Heygere and Mr. Christian Morel will step down from the Board and would like to sincerely thank them for their contribution to the Chamber.

Bart Horsten, whose company is writing the Wechat articles for the Chamber, suggests that our Wechat account is a good way to attract new members and improve the credibility of the Chamber in an organic way. He suggests that members of the Board and General Assembly share BCECC articles via their Moments, and invite their contacts to like and share them. The Chamber has successfully increased its number of followers a lot by having their articles shared by other channels, such as the Wechat account of the Belgian Embassy in China and Limburg in Action. Many of our readers are Chinese entrepreneurs, so Bart suggests to create some more content for a Chinese audience.
